**General Conditions:**

- (a) The engagement of Project Staff which is on contract basis in respect of all above positions will confer no rights on the candidates, whatsoever, implicitly and / or explicitly for their continuation beyond tenure /absorption/ regularization in CSIR. Engagement of Project Staff may be terminated at any time by giving a notice of one month from either side or one-month stipend in lieu thereof.
- (b) Project Staff would be governed by the CSIR Guidelines relating to engagement of project staff in CSIR Projects including NMITLI projects, OLP/MLP, Contract R&D and non-CSIR funded Projects issued by CSIR vide OM No. 4/CMG/2020-TMDII dated 13 August 2020.
- (c) Director, CSIR-NAL reserves the right to increase / decrease the number of positions and also cancel the recruitment process for the positions mentioned above at any stage of the recruitment process. The decision of the Director, CSIR-NAL will be final and binding on all candidates at any stage for engagement of Project Staff.
- (d) The engagement of Project Staff will be subject to production of ORIGINAL documents viz. Educational Qualification certificates, Experience certificate, Caste Certificate etc.
- (e) Candidature will be purely provisional subject to fulfilling the eligibility criteria.
- (f) In case a large number of candidates appear for the interview, the Selection/Screening Committee will have discretion to shortlist the candidates for the interview based on written exam or any other criteria deemed fit. In respect of equivalence clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification for recruitment as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the Application is liable to be rejected.
- (g) List of selected candidates will be displayed on website. In addition, panel of waiting list will also be drawn for future requirements and it will be valid for one year.
- (h) The selected candidates are expected to join within 15 days from the date of receiving the offer letter, after completing the formalities like medical examination, character verification, police verification etc.
- (i) No TA/DA will be paid to the candidates for attending the Walk-in-Interview.
- (j) Canvassing in any form will render the candidate disqualified.

**Age Limit:** 50 years for Project Assistant. 35 years for Project Associate-I & II. The above age limits are relaxable for candidates of statutory groups as per CSIR/Govt. of India instructions on the subject.

**INTERVIEW:**

The **Walk-in-Interview** will be held on **01.08.2022 for Project Associate-I & II and on 02.08.2022 for Project Assistant** from 8.30 am onwards after the completion of the registration at RAB Meeting Complex, National Aerospace Laboratories (NAL), Adjacent to SBI, NAL Branch Kodihalli, Bengaluru – 560017.

The candidates have to report at CSIR-NAL between 8.30 AM to 10.00 AM for registration and verification of documents. Shortlisting of applications will be completed and selected candidates will be informed by 12.30 pm. Interview for selection of candidates will be 1.00 PM onwards

Note: No candidates will be allowed for registration after 10.00 AM.

Candidates are informed to bring filled in applications (available in our website) along with latest passport size photograph, original certificates along with set of Xerox copies including Caste Certificates if any, in the proper format issued by the appropriate authority as per the latest instructions issued from time to time on the subject. If large number of candidates appear for Walk-in-Interview, the Selection Committee will decide the criteria for shortlisting of candidates and Written Test will be conducted, in such case candidates will be informed the criteria fixed by the Selection Committee and accordingly they will be allowed for Walk-in-Interview. Also if any candidate could not be interviewed on first day they will be interviewed on next day. The decision of Director, CSIR-NAL / Selection Committee in allowing any candidate for Walk-in-Interview is final and binding all candidates.

The Selected candidates will have to report immediately and no extension of duty joining date is entertained.

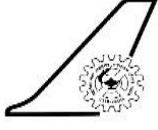
