The eligible bidder who having the Class-I electrical license or equivalent certificate issued by Chief Electrical Inspectorate authorities, Govt of Karnataka or Govt of India or any other state Govt authorities to work on electrical installation, proof of registration with GST, ESI & EPF authorities and satisfactory **work completion certificate for at least three similar works each of value not less than 40% or two similar works each of value not less than 60% or one similar work of value not less than 80 % of estimated cost** as shown in the NIT during the past seven (7) years ending on or before **13.10.2022 or last date of submission of tender whichever is earlier**.
